General Public Comment

Business

18TP033 – Approve the 2019 Unified Planning Work Program – Final Report. Harrington reviewed the 2019 Unified Planning Work Program that includes annual activities, planning studies, and products to be developed by the Metropolitan Planning Organization for 2019 and also identifies funding and staffing for conducting these tasks.

Rick moved, Raymond seconded and motion carried unanimously to approve the 2019 Unified Planning Work Program – Final Report.

18TP034 – Approve the Agreement between the City of Rapid City and the South Dakota Department of Transportation for accomplishing the Rapid City Area Transportation Planning Process in the amount of \$972,117. Harrington reviewed the Agreement that provides federal transportation planning funds in the amount of \$972,117 to conduct activities identified in the Rapid City Area Metropolitan Planning Organization's 2019 Unified Planning Work Program and authorizes reimbursement of funds to the City of Rapid City for work identified in the 2019 Unified Planning Work Program.

Rick moved, Boylan seconded and motion carried unanimously to approve the Agreement between the City of Rapid City and the South Dakota Department of Transportation for accomplishing the Rapid City Area Transportation Planning Process in the amount of \$972,117.

18TP036 – Acknowledge the 2013-2017 Coordinated Public Transit-Human Services Transportation Plan Annual Update. Brennan reviewed the 2013-2017 Coordinated Public Transit-Human Services Transportation Plan Annual Update that identifies the 2018 accomplishments, on-going tasks, those not yet initiated, and those scheduled for next year.
